AGREEMENT

CONTRACT: I am an independent contractor assuming all responsibility for money and prizes received as a result of my activities and participation including, without eliminating, income tax, FICA, state taxes, workers compensation and withholding taxes. I am not an employee, servant or agent of Madison Speedway, Inc.
BENEFITS: I agree that myself, my executors and assigns will be entitled only to the benefits of the Competitor Accident Policy procured by Madison International Speedway for accidental injuries which are a result of external violent and visible means sustained in Madison International Speedway events. The foregoing shall constitute the limit of liability of Madison International Speedway for such injuries occurring to me at Madison International Speedway events provided proper notification is given.
COMPLIANCE: I agree to abide by all rules and regulations of Madison International Speedway now published or hereinafter modified. In consideration of the acceptance by Madison International of this agreement, I recognize my obligation to the public and Madison International Speedway, which posts prize money and conducts the event, and agree to compete in all events when qualified, if humanly possible.
BREACH & DAMAGE: In the event that I, or my assigns, breach this agreement, I shall be liable for the actual and liquidated damages sustained by Madison International Speedway.
OWNERSHIP: I certify that I have good, marketable title to the competition vehicle(s), free from liens and encumbrances, and will deliver goods and marketable title to said vehicle or any part thereof in the event the same is claimed, pursuant to the rules of Madison International Speedway.
SOCIAL MEDIA: Madison International Speedway's 2021 Social Media Policy states: "Even though [social media] may seem informal, as a competitor or official of MIS you are still expected to act in a professional manner at all times. Ultimately, you are solely responsible for what is posted online. Before creating online content or allowing others the ability to post online content for you, consider some of the risks & rewards that are involved. Keep in mind that any of your conduct that adversely affects Madison International Speedway, other members, or others may result in disciplinary action up to and including suspension."
ADVERTISING RELEASE: I consent to the use of my name, pictures of myself and my car for publicity, advertising and endorsements both before and after the events, and relinquish any rights to photos, video or broadcast taken in connection with events. I consent to the publication and sale of such photos as Madison International Speedway so desires. I further relinquish any fights for broadcast, publication, capture or print of my name and likeness.
ARBITRATION: Any controversy or claim arising out of or relating to this agreement, including any alleged breach, shall be settled in accordance with the rules and regulations of Madison International Speedway and I agree to accept the decision rendered by this process.
RELEASE & WAIVER: I acknowledge that by signing the release and waiver at each race event, in exchange for admittance to restricted areas, I have waived legal rights, to sue for injuries, including death, and acknowledged the potentially dangerous nature of activities in and adjacent to restricted areas.
